6. Recognition

a. J. Gazdovich – Awarded Three Week Scholarship to attend CERN (European Organization for Nuclear Research)

Superintendent Mirand and President O'Malley presented a certificate to Jennifer Gazdovich, Teacher at Kenmore West High School, in recognition of the three week scholarship she received to attend CERN (European Organization for Nuclear Research) near Geneva Switzerland, to study physics with others from around the world.

7. Presentations

a. Preparing Ken-Ton Students: College & Career Readiness – The Benefits of Internships – Kenmore East High School – P. Heyden, W. Cox

Principal Patrick Heyden and Business Teacher Wendy Cox, gave a brief overview of the internship program at Kenmore East High School. Students complete a total of 54 hours outside of the classroom in their internship. Students Matthew and Taylor then told the Board about their specific internships and the advantages of participating in this program. They also discussed the connection to the classroom, and the classes they are taking in school, that directly relate to the field in which they are completing their internship. The students maintained that the intern opportunities assist when making choices regarding colleges and careers.

b. What We Think About When We Think About Assessment: Formative Assessment – C. Huber, H. Lyon

Directors, Dr. Huber and Dr. Lyon, gave the second presentation in their series on assessments to the Board. The focus this month was on formative assessment or checking for understanding. The Directors explained how formative assessment can shift the learning to the learners, and how formative assessment in the classroom is part of the teaching and learning cycle. They also discussed types of informal and formal formative assessments, and the importance of learning targets and student self-assessment.

Tara Sciortino, 18 Old Colony Ave., publicly thanked a Hoover Middle School administrator for quickly addressing concerns regarding her child. She also thanked the Board for supporting and caring about students.

Teresa Cianchetti, 1719 Parker Blvd., commented on the 16-17 school day and the District's homework policy.

J. Kirby Harris, 69 Irene St., asked for assistance in accessing information on consolidation, school start and end times and transportation, and spoke positively about the work the District is doing to support students.

Colleen Freeman, 318 Argonne Dr., addressed the 16-17 end times for elementary schools.

Kastle Freeman, 318 Argonne Dr., requested additional communication from the District to parents regarding 16-17 bell times and schedules for next year.

9. Board of Education

a. Resolution to Approve Ex Officio Student Board of Education Member Proposition [Action Item]

At the request of President O'Malley, a motion was made by Trustee Potter, seconded by Trustee Dana, to approve the following resolution:

Section 1. At the annual meeting of the qualified voters of the Kenmore-Town of Tonawanda Union Free School District (the "District") to be held on May 17, 2016, the following proposition shall be submitted to be voted upon:

PROPOSITION

RESOLVED, that the Board of Education of the Kenmore-Town of Tonawanda Union Free School District is hereby authorized to have a student attending high school within the District serve as an ex officio student member of the Board of Education; such ex officio student member being entitled to sit with Board of Education members at all public meetings of the Board of Education and participate in all Board of Education hearings and meetings, but not vote, attend executive session, and/or be entitled to receive compensation of any form for participating at Board of Education meetings; and

BE IT FURTHER RESOLVED, that the Board of Education of the Kenmore-Town of Tonawanda Union Free School District is authorized to establish a process for selection of such ex officio student member of the Board of Education pursuant to Education Law §1702.

Section 2. The District Clerk is hereby authorized and directed to include within the notice of said annual meeting required to be published and posted by the District, a statement to the affect that the proposition set forth in Section 1 of this resolution will be voted upon at such annual meeting, which notice shall contain the full text of such proposition.

Trustee Potter requested that wording in the proposition be changed from "...is hereby authorized to have a student attending high school **within the** District serve as an ex officio student member of the Board of Education;" to "...is hereby authorized to have a student attending **a** high school **of the** District serve as an ex officio student member of the Board of Education;".

A motion was made by Trustee Dana, seconded by Trustee Potter to approve the Ex Officio Student Board of Education Member Proposition as amended.

11. Superintendent's Report - D. Mirand

a. Consolidation Update

Superintendent Mirand stated that the State Education Department has released the District from its Focus District designation after four years, and thanked all faculty and staff, and in particular Principals Johnson and Heyden, and Assistant Superintendent Zymroz for their hard work in this effort.

Superintendent Mirand also gave the Board an update on the consolidation process. The rationale for, and variables impacting the 16-17 start and end times, was detailed and posted on the District website. The transportation schedule, number of buses needed to accommodate Consolidation Scenario I, as well as the new walking limits are constraints. There are many events and activities planned for parents and students to commemorate the closing buildings and facilitate a smooth transition process. The stakeholder committee will be meeting to offer advisement on repurposing vacant buildings in mid-March. The transfer process for instructional and non-instructional staff should be completed in early April and the moving process will be put in place. All paperwork required to close buildings and reconfigure grade levels has been submitted to the State. The team is working tirelessly to finalize information.

b. MOA Between Ken-Ton & Charter School for Applied Technologies (CSAT) Regarding Ken East Football – B. Banker [Action Item]

Athletic Director, Brett Banker presented a proposal to the Board for the sharing of opportunities and resources between the Kenmore East football program and the Charter School for Applied Technologies (CSAT). Director Banker explained the proposal, why the agreement is being sought, and how it would benefit the Kenmore East program. Board members asked many questions. Head Coach Veltri and CSAT Athletic Director Reed were also in attendance to answer questions.

A motion was made by Vice President Gianni, seconded by Trustee Potter to approve the Memorandum of Agreement between the District and the Charter School for Applied Technologies to share opportunities and resources for interscholastic football.

Discussion ensued with each Board member commenting. Several suggestions were made and discussed, including revisions to the agreement. The Board agreed that they would like to hear more options at the March 29th Budget Work Session before moving forward.

Vice President Gianni made a motion, seconded by Trustee Potter to withdraw his previous motion to approve the Memorandum of Agreement between the District and the Charter School for Applied Technologies to share opportunities and resources for interscholastic football, and table the discussion until the 3/29/16 meeting.

Resolution to Approve Bus Purchase Proposition [Action Item]

Assistant Superintendent Brucato briefly reviewed the resolution for the purchase of 13 buses.

At the recommendation of Superintendent Mirand, a motion was made by Trustee Dana, seconded by Trustee Potter, to approve the following resolution:

BE IT RESOLVED, that the Board of Education of the Kenmore-Town of Tonawanda Union Free School District, in the County of Erie, New York (the "District"), is hereby authorized to purchase the following vehicles (and related equipment) for use in the transportation program of the District: eight (8) 65-passenger school buses at an estimated maximum cost of \$114,621 each, two (2) 65-passenger school

buses at an estimated maximum cost of \$116,356 each, three (3) 65-passenger school buses at an estimated maximum cost of \$114,019 each, for an aggregate maximum cost of \$1,491,738, and to expend therefor, including for preliminary and incidental costs relating thereto and to the financing thereof, an amount not to exceed the estimated maximum cost of \$1,491,738 and that the sum of \$1,491,738 (or so much thereof as may be necessary, plus an amount necessary for the payment of interest thereon) shall be raised by the levy of a tax upon the taxable property of the District and collected in annual installments as provided by Section 416 of the Education Law, and, in anticipation of such tax, bonds or other obligations (including, without limitation, obligations arising under leases, lease/purchase contracts or installment purchase contracts having a term of not more than five years) of the District shall be issued or entered into in accordance with applicable provisions of New York State law.

• Resolution to Approve Capital Reserve Fund Proposition [Action Item]

At the recommendation of Superintendent Mirand, a motion was made by Trustee Dana, seconded by Vice President Gianni, to approve the following resolution:

Motion by Trustee Dana, seconded by Vice President Gianni to adopt the following resolution (i) to authorize the establishment of a Capital Improvements Reserve Fund of the District in the ultimate amount of fifteen million dollars (\$15,000,000) and (ii) to provide for certain additional details with respect thereto:

BE IT RESOLVED, by the Board of Education (the "Board") of the Kenmore-Town of Tonawanda Union Free School District, Erie County, New York ("District"), as follows:

Section 1. The Board has determined that it is appropriate and in the best interests of the District to seek from the voters of the District their approval for the establishment of Capital Improvements Reserve Fund (the "Fund").

Section 2. Such Fund is to be established for the purpose of financing, in whole or in part, the District's activities in acquiring, constructing, reconstructing, adding to, renovating, altering and improving District buildings, facilities, grounds and real property, including the acquisition of original furnishings, equipment, machinery and apparatus required in connection therewith.

Section 3. The Board wishes to set the ultimate amount of such Fund at fifteen million dollars (\$15,000,000), and the probable term of such Fund at ten (10) years.

Section 4. The Board wishes to submit to the voters of the District a proposition with respect to the establishment of such Fund, with such proposition to be voted upon at the annual meeting and vote of the District that is to be conducted on May 17, 2016.

Section 5. Such Fund shall be deemed approved for further action by the Board upon the approval thereof by a majority of the qualified voters of the District voting on a duly presented proposition on such day.

Section 6. The proposition to be so submitted shall be in substantially the following form:

Proposition No. 3 - Establishment of Capital Improvements Reserve Fund

Shall the following resolution be adopted, to wit:

RESOLVED, that the Board of Education (the "Board") of the Kenmore-Town of Tonawanda Union Free School District (the "District") is hereby authorized to establish a capital reserve fund pursuant to Section 3651 of the Education Law of the State of New York (the "Fund"); that the Fund shall be known as the "Capital Improvements Reserve Fund" of the District; that the Fund shall be established for the purpose of financing, in whole or in part, the District's activities in acquiring, constructing, reconstructing, adding to, renovating, altering and improving District buildings, facilities, grounds and real property, including the acquisition of original furnishings, equipment, machinery and apparatus required in connection therewith; that the ultimate amount of such Fund shall be not greater than fifteen million dollars (\$15,000,000) plus interest earned thereon; that the probable term of such Fund shall be not longer than ten (10) years but such Fund shall continue in existence for its stated purpose until liquidated in accordance with the Education Law; and that the permissible sources from which the Board is authorized to appropriate monies to such Fund from time to time shall be (a) current and future unappropriated fund balances from the General Fund of the District, (b) State aid received as reimbursement for expenditures by the District in connection with District capital improvements (whether or not financed in whole or in part from such Fund), (c) the proceeds from the sale of unneeded District real or personal property and (d) such other sources as the Board or the voters of the District may direct.

Section 7. This resolution shall take effect immediately.
