This memo (this "Memo") is intended to summarize the principal terms of a proposal being considered by North Tonawanda City School District ("Buyer") regarding its possible acquisition of wheelchair bus 406 of Kenmore —Town of Tonawanda UFSD ("Seller"). The possible acquisition of bus 406 is referred to as the "Transaction" and Buyer and Seller are referred to collectively as the "Parties."

- 1. <u>Acquisition of Asset and Purchase Price.</u>
- (a) Subject to the satisfaction of the conditions described in this Letter, at the closing of the Transaction Buyer would acquire the asset free and clear of all encumbrances, at the purchase price set forth in Section 1(b).
- (b) The purchase price for the Asset would be \$ 3,000 (the "Purchase Price") in check issued by the Buyer.
- 2. <u>Conditions</u>. Buyer's obligation to close the proposed Transaction will be subject to customary conditions, including:
- (a) Buyer's satisfactory completion of due diligence;
- (b) the Board of Education of Seller and Buyer approving the Transaction;
- (c) there being no material adverse change in the condition of the asset before completion of the Transaction.
- 3. <u>Due Diligence</u>. From and after the date of this Memo, Seller will authorize its management to allow Buyer and its staff full access to the asset for the purpose of completing Buyer's due diligence review. The due diligence investigation will include, but is not limited to, a complete review of the condition of the asset.
- 4. <u>Offer Expiration</u>. This offer will remain in effect until August 30, 2017, unless accepted or rejected by Seller, or withdrawn by Buyer prior to that time.
- 5. <u>GOVERNING LAW</u>. THIS TRANSACTION SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH INTERNAL LAWS OF THE STATE OF NEW YORK,
