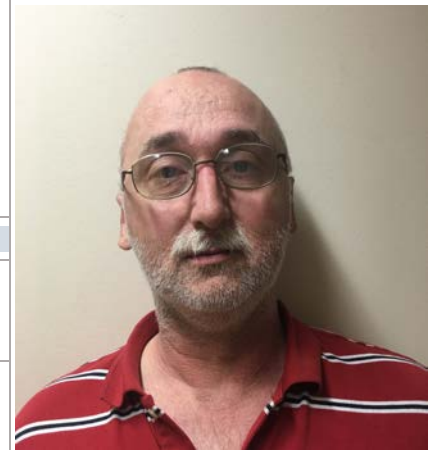

Determination of a level 2 status allows for dissemination of crime conviction information and zip code to the vulnerable population of the community. A level 2 status classifies the offender as a moderate risk to the community.

Determination of a level 3 status allows for dissemination of the offender's picture, description, exact address, address of his employment, crime of conviction, the mode of operation, type of victim targeted, name and address of any institution of higher education at which the offender is enrolled or attends. A level 3 status classifies the offender as a high risk to the community.

Access to New York State Sex Offender Registry information is governed by Correction Law Article 6-C. Pursuant to Correction Law Section 168-b (2)(e), no information in the Registry shall be made available except in furtherance of the provisions of the Sex Offender Registration Act (SORA). Unauthorized release of Registry information is a crime. Anyone who uses this information to injure, harass, or commit a criminal act against any person may be subject to criminal prosecution.

This information is being sent to the vulnerable entities of the community related to the nature of the offense committed. Any entity receiving information on a sex offender may disclose or further disseminate such information at its discretion (Correction Law 168-1-6-c).
