01:43 JILL: Okay, I think that was Andrew and then second by Michelle? Okay, Gina. Go ahead.

01:52 GINA: Alright, the final results after tallying the rest of the votes that couldn't go through the machine: Proposition I, which was the budget. The final number: Passed 7,164 to, the no votes were 2,664. Proposition No. 2, which was the bus proposition, yeses were 7,460, nos were 3,039. And then Proposition 3 was the Establishment of the Capital Reserve. Yeses were 7,650 to nos 2,818. And then the board candidates, the top two vote-getters got the seats to the board: Leslie Battaglia had 5,788 votes; McKinley Falkowski had 3,042; Jennifer Morrow had 4,820; and Dawn Stinner had 4,818. The machine counted 10,799 ballots, 20 were hand-counted, and there was another 589 ballots that could not be verified for a total of 11,408 ballots that were submitted. And the ones that couldn't be verified we tried two, three, four times to verify and they just couldn't for various reasons. Most of them were there was no signatures, so they couldn't be verified as a qualified voter. There were a few that just had signatures and no addresses, we had no way to search and it was illegible, so we couldn't find out who the voter was.

03:37 JILL: Yeah, I want to point out that we also received... People sent in a dog license permit, and a check, people sent in state ballots, so it was a really confusing process, I think, for people. I'm glad that the budget went our way, but it was really disheartening to see some of the ways that people... I think they wanted to participate in the vote, but just "It was what it was" kind of a thing. I want to take a moment to thank Gina for all your hard work. I know you've been working on this diligently since May 1st. This has been extraordinary for district clerks across the state but it was so organized. I was down at the Board of Elections for ECSB and then stayed on while the Ken-Ton count happened. They brought the boxes up, the boxes had zip ties through them, and then they were unlocked in the presence of the elections workers and I can't say enough about those election workers as well. There was three or four of them in the room at any given time, we... Again, a testament to Gina's organization. She had talked to the printer, had the printer talk to the Board of Elections. We were one of the few districts that really had everything exactly how it was supposed to be. The correct size of the ballot, the weight of the ballot. And it really expedited things. Of course, some of you may have seen in the middle of our counting the fire alarm went off last night, so we had to leave and go across the street. You really cannot even make up what happened during this election. And thanks to Steve and John for also being there, but Gina really... You were a rock star during this, we were lucky to have you, keeping us organized, so thank you.

05:28 GINA: And I want to thank... I had a lot of help, too. I couldn't have done it by myself and I want to thank my group, too. Jean Weglarski was awesome and Cheryl Shepherd, Donna Mesmer, alphabetizing for two weeks. And then I had a crew of 12 people that just worked their tails off on Tuesday to get it done and I had a great group, too, that helped us get through it.

05:50 JILL: And of course for Patrick, for his technology support for the live stream. That was, I think, important for our community to be able to see that. I know it was extra work but I think it was worth it. I'm not sure how many people sat and watched the whole... Well, how long were you there? You said 7 in the morning until what?

06:12 GINA: And I didn't think we'd get it done on Tuesday, but that's a testament. We worked right through for those 15, 14 hours and so I owe a lot to my... The people that came in and helped me, too.

07:28 JILL: "So moved" by Matt, second by Andrew. Any discussion? There being... Oh, go ahead.

07:33 ANDREW: Sorry. I just wanted to ask that this seems... I understand that this is sort of based on our need to do this now. John, can you speak to the parenthetical "possible" in this?

07:49 JOHN: With this project, all component districts have to... Excuse me... Have to finance and basically put their proportionate share for this work so this won't hit our budget year until 2021. But what this is doing is it's authorizing our intent to be part of the component group that are financing

this capital project for BOCES.

08:14 ANDREW: Right, is this just because we haven't actually approved the capital project for BOCES?

08:20 JOHN: This is just authorizing our intent to fund and to potentially borrow money for it. All the districts have had to do this just really say that we're going to potentially finance, or fund it in another manner, to push our proportionate share to the project.

08:41 ANDREW: Okay. And so the parenthetical possible is simply that we're committing to funding it and if that means that we need a bond for it, that we will, and if we don't need a bond for it, then we won't, but this is showing a commitment to Erie 1 BOCES. I just... The "possible" piece is the thing that threw me.

08:55 JOHN: Yeah.

08:56 ANDREW: Because we're provisionally approving a bond that we may not take out which is, I don't think, usually how we would do something. But that makes sense, this is a commitment to funding that may require a bond. Thank you.
