**7. Presentations****a. Hoover Elementary School – iFitness...Using Technology in Physical Education To Create Dynamic Classes For All Fitness Levels – M. Huff**

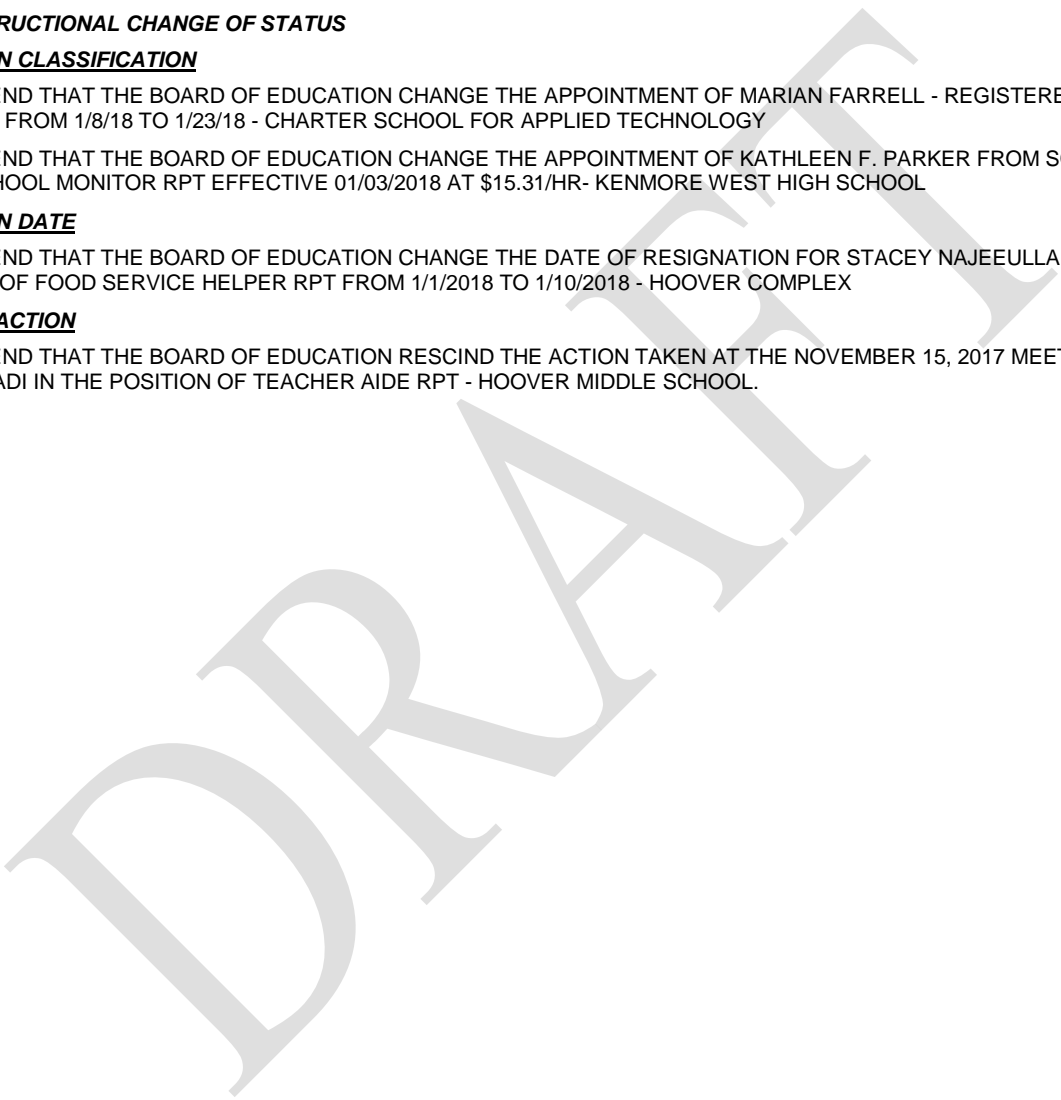
