BE IT FURTHER RESOLVED that Bus #342 and Bus #358 shall be donated by the Kenmore-Town of Tonawanda Union Free School District to the Sheridan Park Fire District No.4.

BEIT FURTHER RESOLVED that Bus #342 and Bus #358 will be donated in their "as is" condition, without any warranties by the School District, and on the condition that the recipient shall hold harmless for any claims arising out of the property after the transfer of titles to the recipient.
