Superintendent Bovino gave an update on the District which included the progress on the new community room at the Kenmore Middle School building, the moving of the last two departments from the Sheridan Building to Kenmore Middle School, the 1<sup>st</sup> Strategic Planning Committee meeting and the Community Forum.

**b. Instruction & Student Services – R. Zymroz**

- **Columbia University Coaching Institute on the Teaching of Writing – C. Gruber, S. Terrance**

Instructional Coaches Sandy Terrance and Cathy Gruber gave the Board an overview of the Columbia University Coaching Institute on the Teaching of Writing that they attended in New York City. They were able to network with literacy coaches from across the country and put their learning immediately into practice inside the classrooms of New York City. This knowledge will be passed on to the teachers in Ken-Ton through professional development opportunities that are being planned for them and their everyday coaching and modeling.

- **Social/Emotional Wellness Presentation – M. Lewis, J. Cerra, E. Ablove**

Directors Lewis, Cerra and Ablove gave a joint presentation to the Board regarding social/emotional health and wellness in Ken-Ton. The program cycle was explained, and each Director spoke about how their program/department is directly addressing the social and emotional health and wellness of Ken-Ton's students during each phase of the cycle. Board members asked several questions at the conclusion of the presentation.

Assistant Superintendent Zymroz addressed some additional questions from Board members regarding the American Reading Framework.
