Who: Families of any Kenmore West or Kenmore East Senior

1. **What:** **Free** assistance for students/families with filling out the **2024-2025 FAFSA/TAP Forms & college applications**

Where: You can choose one of the following two options:

1. **In -Person Appointment** - Ken-Ton Family Support Center, 255 Myron Avenue, Kenmore (located behind Kenmore Middle School). You will need to enter through the side door (DOOR # 7) on the North side of the building.
(Type - “KenTon Family Support Center” in GPS)
2. **Virtual Appointment** - upon registration you will be sent a Google Invite. **The device that you use MUST have a functioning camera.**

GET READY to file the 2024-25 FAFSA & TAP Applications

MUST GET YOUR FSA ID NOW!

- The FSA ID is the username and password students will use to access all Federal Student Aid websites, including FAFSA.gov. It takes about 15 minutes to create an FSA ID. We strongly recommend creating FSA IDs ahead of time. **For dependent students, at least one parent will also need to create an FSA ID to sign the FAFSA.**
- To create and learn more about the FSA ID, go to [FSAID.ed.gov](https://fsaid.ed.gov).

Dependent students will need the following information:

- Your and your parent's FSA ID
- Your and your parent's Social Security numbers
- Your and your parent's 2022 Federal **AND** State income tax returns (including all applicable schedules), 2022 W-2 forms and other records of money earned
- Your and your parent's current bank statements

If applicable, you will also need...

- Your and your parent's driver's license (if applicable)
- Your and your parent's 2022 untaxed income information
- Your and your parent's current business and investment mortgage information, business and farm records, stock, bond and other investment records
- Your alien registration or permanent resident card (if you are not a U.S. citizen)

REPORTABLE ON FAFSA:

- * Cash, checking and savings
- * Real estate (other than home you live in)
- * Financial assets, such as stocks, bonds, certificates of deposit, mutual funds, money market accounts
- * UGMA/UTMA accounts
- * College Savings Plans, including 529 plans & Coverdell accounts (list as a parent asset)

NON-REPORTABLE:

- * The home you live in
- * Retirement plans
- * Any family-owned business w/ less than 100 full-time employees and
- * The family farm
- * Life insurance policies
- * Personal possessions, such as cars and boats

GET READY to fill out your Fall 2024 College Applications

College Application Checklist:

- List of Schools applying to
- Submission Deadlines (Regular, Early Action/Decision, Rolling)
- Personal Information - emails, phone numbers, college credits earned, standardized test scores
- Extracurriculars - activities you've done outside of class (clubs, activities, sports, work, honors)
- Essay, Letters of Recommendation, application fees (if required)
- When finished notify school counselor you've applied
