

### **APPEALS**

According to Subpart 30-3 of the Rules of the Board of Regents, "nothing shall be construed to alter or diminish the authority of the governing body of a district to grant or deny tenure to or terminate probationary (educators) during the pendency of an appeal pursuant to this section for statutorily and constitutionally permissible reasons, including the educator's performance that is the subject of the appeal."

- 1. A teacher may appeal the improvement plan for the reasons stated above in accordance with the appeals process procedure.
- 1. Where and to the extent applicable, the Annual Professional Performance

Review of classroom teachers shall be a significant factor for employment decisions and teacher development, and will be subject to any procedures which may in the future be negotiated by the District and the Association as well as a material change application through the State Education Department.

1. A unit member holding the position of classroom teacher may appeal only the substance of the Annual Professional Performance Review, the District's adherence to the standards and methodologies required for such review, and the District's compliance with its procedures for conducting the Annual Professional Performance Review, or its issuance and/or implementation of the terms of the Teacher Improvement Plan. Such appeal must be submitted in writing to the Administrator performing the Annual Professional Performance Review or Teacher Improvement Plan. The writing must explain in detail the specific basis for the appeal. The appeal must be submitted within five calendar days of the issuance of the Annual Professional Performance Review or Teacher Improvement Plan, or other act under this section which is the subject of the appeal, or it is deemed waived. Nothing shall be construed to authorize a teacher to commence the appeal process prior to receipt of his/her rating from the District. Within ten calendar days of receipt of the appeal, the Administrator conducting the Annual Professional Performance Review or Teacher Improvement Plan shall submit a written determination. The absence of a determination shall be deemed a denial of the appeal. If the teacher received an "ineffective" or "developing" rating and disagrees with the determination, the teacher may submit a copy of the appeal, the determination, and a written statement explaining in detail the disagreement with the determination, to a Labor-Management Panel within five calendar days of the date of the determination. The Labor-Management Panel will consist of the Superintendent (or his designee), the KTA President (or his designee), and a third person to be determined by the other two panel members. If the other two members are unable to agree on a third member, the third member shall be selected by random draw from a pool consisting of two teachers, selected by the KTA President, and two administrators, selected by the Superintendent, all of whom shall have had at least one year of service, past or present, on the Mentor Policy Board. The Labor-Management Panel shall provide the teacher with the opportunity to meet with the Panel within five calendar days of the date the teacher's request was received (or such other convenient time as may be determined by the Panel), and shall render a final determination on the appeal within ten calendar days after the date on which the teacher was provided the opportunity to meet with the Panel. This process shall be timely and expeditious according to Educational Law 3012-d.

Impartial independent observers will receive training on the three requirements prescribed in subpart 30-3.10(c).

Training for all evaluators, lead evaluators and independent evaluators will be conducted within the district by teacher and principal leaders on career ladder pathways and will consist of a minimum of five school days throughout the school year. Inter-rater reliability will be maintained over time through various activities, including data analysis to detect disparities on the part of one or more evaluators, periodic comparisons of a lead evaluator's assessment with another evaluator's assessment of the same educator, and annual calibration sessions across evaluators.

Certified school administrators or superintendents of schools serving as lead evaluators will not be prohibited from conducting classroom observations or school visits as part of an APPR prior to completion of the training required by subpart 30-3.10 provided such training is successfully completed prior to completion of the evaluation.

Evaluators, lead evaluators and independent observers will be re-certified by the Board of Education annually. Additionally, all evaluators, lead evaluators and impartial independent observers will be retrained annually to maintain calibration levels consistent with district expectations.

- 1. Submit in writing to the Superintendent of Schools, a copy of a request for an appeal
- 2. Attach the evaluation which is the subject of the appeal
- 3. Submit a letter for basis of the appeal and attach documentation

Within 10 business days of the Superintendent's receipt of the principal's appeal:

- A panel of two administrators will be appointed to hear the appeal; one administrator appointed by the Association President and one administrator appointed by the Superintendent of Schools
- 2. The Association appointee must be tenured and not actively involved in his or her own evaluation appeal
- 3. The District may not appoint the administrator who wrote the appealed evaluation
- 4. The panel of two shall be given 10 business days to render a written decision, which may be to accept the rating, modify the rating, or come to no mutual agreement. The panel will report their findings to the Superintendent.
- 5. If a mutually agreeable decision cannot be reached by the appeals panel of two, then within 10 business days after notifying the Superintendent, a random drawing by the District Clerk will ascertain whether the District or Association selects the third panel member. This drawing will take place within the ten days after the Superintendent is notified. This paragraph covers only the first evaluation appeal. Subsequent to this first appeal, the District and Association will alternate the ability to appoint the third panel member.
- 6. This panel of three shall render their final and binding decision within 10 business days after the District Clerk or District/ Association ascertains the third member of the panel
- 7. This panel of three will put their decision in writing and submit it to the Association President, the Superintendent of Schools, the Evaluator, and the Principal.

# **ELEMENTS OF A TIP**

The exclusive purpose of a TIP is the improvement of teaching practice and the issuing of a TIP is not a disciplinary action.

The TIP shall clearly specify: (i) the area(s) in need of improvement; (ii) the performance goals, expectations, benchmarks, standards and timelines the teacher must meet in order to achieve an effective rating; (iii) how improvement will be measured and monitored, and provide for periodic reviews; and (iv) the appropriate differentiated professional development opportunities, materials, resources and support the District will make available to assist the teacher.

There will be one form completed for each area that has been found to be in need of improvement.

The teacher, principal and a union representative will meet to discuss the contents of the TIP before implementation. The principal and the union representative will agree to the final TIP's contents.

If the District directs the teacher to obtain books or materials, or to attend a particular seminar or course, the costs of such books, materials, and/or seminars/courses shall be paid by the District (and the teacher will receive whatever benefits for which he/she would otherwise be eligible in our contract).

# USE OF TIP

The artifacts and evidence of the TIP will be used during that school year in an ongoing basis in determining if the professional development included in the TIP is providing the teacher with the necessary tools to make improvement in the areas that were determined to be deficient. If there continues to be areas that need improvement during the year in which the TIP is in effect, the Plan will be reviewed and to the extent warranted modified by those involved in the original TIP creation in an effort to make the teacher successful.

# TIME FRAME FOR TIP

The TIP must be implemented no later than 10 days after the teachers are required to report at the beginning of the next school year.

Assure that the APPR Plan will be filed in the district office and made available to the public on the district's or BOCES' website no later than September 10th of each school year, or within 10 days after the plan's approval by the

Commissioner, whichever shall later occur;

 Assure that accurate teacher and student data will be provided to the Commissioner in a format and timeline prescribed by the Commissioner;

Assure that, during the 2015-16 through 2018-19 school year, the district or BOCES will continue to report both the
original and transition individual category and subcomponent scores and the overall original and transition ratings to
the State for each classroom teacher and building principal in a manner prescribed by the Commissioner;

Certify that the district provides an opportunity for every classroom teacher and building principal to verify the subjects and/or student rosters assigned to them;

Assure that teachers and principals will receive timely and constructive feedback as part of the evaluation process;

 Assure that any training course for lead evaluator certification addresses each of the requirements in the regulations, including specific considerations in evaluating teachers and principals of English language learners and students with disabilities:

Assure that, during the 2015-16 through 2018-19 school years, any educators who receive a Developing or Ineffective
rating as their overall transition rating will receive a Teacher Improvement Plan or Principal Improvement Plan, in
accordance with all applicable statues and regulations, by October 1 in the school year following the school year in
which such teacher's or principal's performance is being measured or as soon as practicable thereafter.

Assure that, beginning in the 2019-2020 school year, any educator who receives a Developing or Ineffective rating on
their original overall rating pursuant to this APPR plan will receive a Teacher Improvement Plan or Principal
Improvement Plan, in accordance with all applicable statutes and regulations, by October 1 in the school year following
the school year for which such teacher's or principal's performance is being measured or as soon as practicable
thereafter:

Assure that such improvement plan shall be developed by the superintendent or his/her designee in the exercise of
their pedagogical judgment, and shall be subject to collective bargaining to the extent required under Article 14 of the
Civil Service Law:

Assure that all evaluators and lead evaluators, including independent evaluators and peer evaluators, as applicable, will
be properly trained and that lead evaluators will be certified and recertified as necessary in accordance with all
applicable statutes and regulations;

 Assure that the district or BOCES has collectively bargained appeal procedures that are consistent with the statute and regulations and that they provide for the timely and expeditious resolution of an appeal to the district/BOCES;

 Assure that, for teachers, all observable NYS Teaching Standards/Domains of the selected practice rubric are assessed at least once a year across the total number of annual observations and, for principals, all observable ISLLC 2008 Leadership Standards/Domains of the selected practice rubric are assessed at least once a year across the total number of annual school visits;

Assure that it is possible for a teacher or principal to obtain each point in the scoring ranges, including 0, for each
subcomponent and that the district and BOCES shall ensure that the process by which weights and scoring ranges are
assigned to subcomponents and categories is transparent and available to those being rated before the beginning of

each school year;

 Assure that if a second measure for the Student Performance category is locally selected, then the same locally selected measures of student growth across all classrooms in the same grade/subject in the district/BOCES must be used in a consistent manner to the extent practicable;

 Assure that all growth targets represent a minimum of one year of expected growth, as determined by the superintendent or another trained administrator;

Assure that any material changes to this APPR Plan will be submitted to the Commissioner for approval by March 1 of
each school year, on a form prescribed by the Commissioner, to the Commissioner for approval;

 Assure that the alternate SLOs described in Tasks 2 and 7 of this APPR plan will be used as the basis for certain teachers' and principals' transition APPR scores and ratings, where applicable and consistent with section 30-3.17 of the Rules of the Board Regents, during the 2016-17 through 2018-19 school years only;

 Assure that, beginning in the 2019-20 school year, no transition scores and ratings will be generated and the district or BOCES' original APPR Plan will apply to all classroom teachers and building principals as defined in the statute, regulations, and SED guidance without any modifications, substitutions, or replacements as a result of the requirements of §30-3.17 of the Rules of the Board of Regents;

Assure that the district or BOCES will provide the Department with any information necessary to conduct annual

monitoring pursuant to Subpart 30-3 of the regulations;

Signatures, dates

Assure that the amount of time devoted to traditional standardized assessments that are not specifically required by State or Federal law for each classroom or program of the grade does not exceed, in the aggregate, one percent of the minimum in required annual instructional hours for such classroom or program of the grade; and

Assure that the amount of time devoted to test preparation under standardized testing conditions for each grade does
not exceed, in the aggregate, two percent of the minimum required annual instructional hours for such grade. Time
devoted to teacher administered classroom quizzes or exams, portfolio reviews, or performance assessments shall not
be counted towards the limits established by this subdivision. In addition, formative and diagnostic assessments shall
not be counted towards the limits established by this subdivision and nothing in this subdivision shall be construed to
supersede the requirements of a section 504 plan of a qualified student with a disability or Federal law relating to
English language learners or the individualized education program of a student with a disability.
