


CODE OF CONDUCT INFORMATION FOR FAMILIES

2023-2024



The Kenmore-Town of Tonawanda Union Free School District is committed to providing a safe environment for students, staff, and visitors. Responsible behavior by students, teachers, support staff, other district personnel, parents, guardians and visitors is essential to achieving this goal. The District has a long-standing set of expectations for conduct on school property and at school functions. These expectations are based on the principles of civility, mutual respect, citizenship, character, tolerance, honesty and integrity. The Code of Conduct defines these expectations for acceptable conduct on school property, and identifies the possible consequences of unacceptable behavior to be administered promptly and fairly.

This document provides a general outline for families of The District's Code of Conduct. The complete text is available for review on The District's website or can be accessed directly by scanning the QR code above.

Some other areas addressed in the Code of Conduct but not highlighted in this document are the following: Prohibited Student Conduct, Electronic Communication Device Code, Alternative Instruction/Programs, Bus Rules, Corporal Punishment, Student Searches and Interrogation, Disciplinary Procedures, Penalties and Referrals, Discipline of Students with Disabilities.

The Ken-Ton District will continue to prioritize a strong partnership with families to ensure the best learning experience for all students. We look forward to another successful school year.



Our District is Committed to Using a Restorative Approach to Discipline

Restorative Practices encompass an approach based on fostering relationships, strengthening understanding, repairing harm, and building strong communities. This is accomplished by identifying and addressing the needs and harms that occur when there is conflict in the school community through the process of cultivating empathy and modeling conflict resolution skills. The purpose is to create meaningful relationships, which are central to building thriving communities. The goal of the Restorative Practices approach is to shift the focus to repairing harm and restoring the relationship hurt by the action, rather than attending to a predetermined consequence assigned to the rule that was broken. The principles of Restorative Practices are:

- Voluntary participation
- Respect for all involved
- Inclusion and equal voice of all involved
- A focus on harms, needs, and causes
- Consensus-based decision making to repair harm and prevent future harm
- Expanding the capacity of the community to create a just, fair, and meaningful response

Dignity for All Students Act

Each school building has a designated Dignity Act Coordinator whose responsibility will be to coordinate and enforce the Commissioner of Education's regulations set forth as a result of the Dignity for All Students Act. In order to implement this program, selected school personnel will assist the administration in developing and implementing specific prevention activities, including early identification of bullying and other strategies. In addition, the program will include reporting, investigating, remedying and tracking allegations of bullying. Students Rights and Responsibilities

Student Rights

1. To attend school in the district in which one's parent or legal guardian resides.
2. To expect that school will be a safe, orderly and purposeful place for all students to gain an education and to be treated fairly.
3. To be respected as an individual.
4. To express one's opinions verbally or in writing.
5. To dress in such a way as to express one's personality.
6. To be afforded equal and appropriate educational opportunities.
7. To take part in all school activities, including extracurricular events, on an equal basis regardless of race, color creed, religion, religious practice, sex, sexual orientation, gender/gender identity, national origin, ethnic group, political affiliation, age, marital status, or disability.
8. To have access to relevant and objective information concerning drug and alcohol abuse, as well as access to individuals or agencies capable of providing direct assistance to students with serious personal problems.
9. To be protected from intimidation, harassment, or discrimination based on actual or perceived race, color, weight, national origin, ethnic group, religion, or religious practice, sex, gender/gender identity/gender identity, sexual orientation, or disability, by employees or students on school property or at a school-sponsored event, function or activity.

Student Responsibilities

1. To attend school daily, regularly and on time, perform assignments, and strive to do the highest quality work possible and be granted the opportunity to receive a good education.
2. To be aware of all rules and expectations regulating student's behavior and conduct oneself in accordance with these guidelines.
3. To respect one another and to treat others in the manner that one would want to be treated.
4. To express opinions and ideas in a respectful manner so as not to offend, slander, or restrict, the rights and privileges of others.
5. To dress appropriately in accordance with the dress code, so as not to endanger physical health, safety, limit participation in school activities or be unduly distracting.
6. To seek support and information about the available educational programs in order to use and develop one's capabilities to their maximum.
7. To work to the best of one's ability in all academic and extracurricular activities, as well as being fair and supportive of others.
8. To seek support and information about the services available and to seek assistance in dealing with personal problems, when appropriate.
9. To respect one another and treat others fairly in accordance with the District Code of Conduct and the provisions of the Dignity Act. To conduct themselves in a manner that fosters an environment that is free from intimidation, harassment, or discrimination. To report and encourage others to report, any incidents of intimidation, harassment or discrimination.

Student rights are protected by the United States Constitution, the Constitution of New York State, laws promulgated by the federal and state governments, the regulations of the Board of Regents and the regulations and policies of the BOE of the Kenmore-Town of Tonawanda Union Free School District, as well as decisions of federal and state courts. In addition, there are rights that have to do with an orderly educational process.

Student Dress Code

The following standards support a safe and positive learning environment, while minimizing distractions in the school setting. These standards have been established by a representative committee of students, parents, guardians, teachers, support staff, and administrators. The standards apply to all Kenmore-Tonawanda UFSD students independent of age, grade level, or location.

1. Any article that covers a student's head, thereby preventing visibility of the student's face, including but not limited to, hoods and ski masks (excluding religious attire) is prohibited.
2. Any article depicting language, images, or themes that denigrate others on account of race, color, weight, religion, religious practice, ethnic group, national origin, gender/gender identity, sex, sexual orientation, or disability is prohibited.
3. Any article that advertises, displays, or represents themes/symbols related to violence; alcohol or drugs; illegal activities; or drug and alcohol use or abuse, gang related activities, or that are suggestive (of a sexual nature) are prohibited.
4. Controversial symbols or messages that can be reasonably forecast to cause disruption in the school environment and/or to the school's operation or that are lewd, vulgar or indecent are prohibited.
5. Any article that poses (or may pose) a threat to the health, safety, and wellbeing of others (including but not limited to decorative chains, wallet chains, studded bracelets, belts, and/or jewelry) is prohibited.
6. Any article of clothing or device that interferes with the integrity of an exam or test is prohibited.
7. See-through and strapless garments are not to be worn. Modest tanks are appropriate as long as the chest and back areas are covered from the top of the armpit down. Midriffs are to be covered. Exposure of skin between the bottom of the shirt and the top of pants is prohibited.
8. Pants, shorts and skirts are expected to be worn at waist level as they are designed, so that undergarments are completely covered.
9. Pants, shorts, and skirts will be of a modest length. Ripped or cut-up pants that reveal undergarments or show skin in an area between the upper chest and mid-thigh are prohibited.
10. Appropriate soled footwear that does not pose a safety hazard are required to be worn at all times; slippers are prohibited.
11. Outdoor attire including but not limited to coats, jackets, parkas, gloves, and scarves will remain in a student's locker during the school day at all times.
12. For students in grades K-7, backpacks and gym bags will remain in a student's locker during the school day.
13. The use of backpacks in grades 8-12 **require** the consideration of the District's ability for search and seizure (page 39) as well as the health and safety of our students. For example, aisles in classrooms are required to remain clear of backpacks.

Nothing in this policy will be construed to limit the ability of students to wear clothing that allows them to express their gender identity, or to discipline students for doing so.

Students in violation of the Student Dress Code, at the discretion of school officials, ***will be required to cover, remove, or modify any inappropriate article, and if necessary or practical, replace it with an acceptable article.*** The determination as to whether or not a student is in violation of any portion of this Code will be at the sole discretion of building administration.

Refusal to comply with the requests of school officials, and/or repeated Student Dress Code violations may result in disciplinary action, up to and including out of school suspension.

The District Code of Conduct will be distributed and interpreted to all staff and reviewed with all students each year as school reopens. Students will receive an abbreviated pamphlet that summarizes the Code of Conduct and highlights the dress code, student rights and responsibilities, prohibited conduct, and disciplinary options. *Please discuss the code of conduct with your child as partners in this work.*
